SHRI MANUBHAI SHAH: Well, the proposal is under consideration, but it is not part of the above, and we are considering the matter as to whether it will be possible or we should wait for some time

SHRI V. PRASAD RAO: Is it not necessary to immediately expedite it in view of the fact that it is • very necessary to use this acetic acid for the manufacture of pulp for paper boards?

SHRI MANUBHAI SHAH: As far as the manufacture of acetic acid for pulp is concerned. the Sirsilk are already manufacturing the acid, but it is our intention to establish more acetic acid factories. But it does not come out of the statement as it concerns the entire power alcohol industry of India and has nothing to do with one particular by-product factory whether in Boudhan or elsewhere.

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) and (b). Yes, Sir. The manufacture of rice bran oil will be undertaken at an existing industrial unit at Kalyan (Bombay). No import of equipment is involved Production is expected to be established in a year.

SHRI DEOKINANDAN NARAYAN: May I know if this will be in the private sector or the public sector and if in the public sector, what will be

SHRI MANUBHAI SHAH: It is an industrial unit in the private sector which is putting up this plant.

SHRI DEOKINANDAN NARAYAN: May I know, Sir, if Government is going to supply any capital to the factory?

SHRI MANUBHAI SHAH: No, Sir.

SHRI DEOKINANDAN NARAYAN: May I know, Sir, what would be the annual production of this factory and how much rice bran would be required for that production per year?

SHRI MANUBHAI SHAH: About 1500 tons of oil and 1,15,000 tons of rice bran.

SHRI DEOKINANDAN NARAYAN: May I know if it is a fact that this factory would affect the hand-pounded rice industry of India?

SHRI MANUBHAI SHAH: No, Sir. On the contrary, it will help because oil is . . .

SHRI N. R. MALKANI: The remains which will be left after the oil is expelled, will it be good fodder or will it be useless?

SHRI MANUBHAI SHAH: Yes, it will be very good for fodder.

SHRI H. D. RAJAH: I want to know to what use will this oil be put. When there is supposed to be a rice shortage in the country, how is this oil to be equated with the rice from the point of view of its utility?

SHRI MANUBHAI SHAH: Sir, the hon. Member has completely misunderstood it. It is not rice. It is the chilka which is thrown out and not rice at all. Nobody is eating rice bran. It is being used for cattle fodder. On the contrary, put of the 2'5 to 3 million tons of .rice bran which is going to waste or is rotting, if this
