SHRI B. N. DATAR: Exactly that is what was pointed out. There was a slight delay in one case and immediately an enquiry was made.

SHRI B. N. DATAR: We have made it clear here that the report may be lodged either with the Police Station or if the particular complainant so desires, he can address it immediately to the Superintendent.

SHRI K. RAGHURAMAIAH: There are a number of training establishments to train up these Naval cadets. Unlike in the Armed and Air Forces, the Naval Cadets, after passing out of the N.D.C. are given training on our Training Ships for a period of six months.

SHRI V. C. KESAVA RAO: May I know whether previously there was a proposal to start one institution at Vizagapatam?

SHRI K. RAGHURAMAIAH: I would like notice about that. If there was any such proposal, I would like to look into it.

CO-ORDINATION OF UNIVERSITY EDUCATION

•11. SHRI J. H. JOSHI: Will the Minister of EDUCATION AND SCIENTIFIC RESEARCH be pleased to state whether there is a proposal under Government's consideration for the coordination of the University education?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION SCIENTIFIC RESEARCH (DR. K. L. SHRIMALI) : The University Grants Commission have set up a Committee to make recommendations for the maintenance and coordination of the standards of university education.

SHRI J. H. JOSHI: Are Government aware that in point of examination, some Universities are very rigid and some are liberal to a fault with the result that the students have to suffer more particularly where they have to seek admission to the Medical or Engineering and such other colleges and do Government therefore feel the need and urgency of bringing about uniformity in all

Universities in respect of the standards of teaching and examinations?

DR. K. L. SHRIMALI: We realise the importance of coordinating and setting up of standards. In fact the whole purpose of the University Grants Commission is to maintain proper standards. A Committee has been appointed and it is making an enquiry into the whole subject. I shall be able to give the results of this enquiry only after the enquiry has been completed.

INTEGRATION OF SERVICES OFCOMPONENT UNITS OF THE BOMBAY STATE

- «12. SHRI J. H. JOSHI: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether the integration of the services of the component units of the State of Bombay has been completed; and
- (b) how long it is likely to take to decide the seniority of the services?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. Datar): (a) No.

(b) The work relating to equation of posts for the purpose of determining the seniority of the employees is in hand and will be completed very soon. Thereafter, it will take sometime longer to determine the seniority of the employees of the different integrating units.

SHRI GOPIKRISHNA VIJAI-VARGIYA: What action has the Government taken after the reorganisation of States that this integration work is speeded up in all the States?

SHRI B. N. DATAR: The Government called a meeting of the Chiei Secretaries of the various States Certain principles were laid dowr and they are being followed in the various States.

SHRI J. H. JOSHI: May I know \i the Government have received any memoranda from the Government servants of Vidharba, Marathwada and Sourashtra showing their grievances and whether there is any agency to which they can look for their redress?

SHRI B. N. DATAR: In the first place all such representations or complaints are considered by the State Governments. Then they prepare the principles regarding equation of posts and then the gradation list is also prepared and if thereafter there are some complaints received by the Central Government, then it would come into the picture.
