[THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) The Ford Foundation have approved a grant of \$205,500 to Ghandigram for organizing a Pilot Health Service programme in collaboration with the Indian Council of Medical Research and the Government of Madras.

- (b) and (c). The main objectives of the Project are:
  - (i) to determine, through a base line survey, present patterns by which people in the Ghandhigram area meet their health problems; and
  - (ii) to establish and evaluate a modern type of rural health service adapted to India's needs.

A sum of Rs. 32,000 for the baseline survey has been sanctioned by the Indian Council of Medical Research and the work which will commence from April 1958, is likely to last for a period of 18 months."]
