**"PRIMARY HEALTH CENTRES**

\*381. SHRI DEOKINANDAN NARAYAN: Will the Minister of HEALTH be pleased to state:

(a) the number of Primary Health Centres so far opened in each State; and

(b) what medical help will be given from these Centres?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) A statement showing the number of Centres reported by the State Governments to have been opened in N. E. S. Blocks in 1956-57 and proposed to be opened during 1957-58 is placed on the Table of the Sabha.

(b) The Primary Health Centres will provide an integrated preventive and curative medical service in rural areas. The ultimate aim of the Primary-Health Centres will be to provide the following essential services: —

- (a) Institutional and domiciliary medical care, with adequate emphasis on its preventive aspects, amongst others, maternal and child health, school health, and control of communicable diseases.
- (b) Environmental sanitation.
- (c) Health Education.
- (d) Improvement of vital and health statistics, and
- (e) Family Planning.
