tion; the population of lands is of a different type because these have gone through areas where there was no population before. All these things have got to be done before the fullest utilisation of water is availed of. In so far as the Damodar Valley project is concerned, the figure 10.44 lakh acres, the last figure when everything is done-the canals and also the delta area, pick up gears and so on and so forth, which have not been done. Therefore, whatever was the availability, namely, 1,43,000 acres is being utilised. The other difficulties regarding money, water rates, etc., are common in all these. But this is a big thing which constantly under review and examination both by the Planning Commission and the Ministries concerned.

SHRI V. PRASAD RAO: Ιt obvious from the statement that very little of the water from Tungabhadra is being utilised. May I know what further steps are being taken so that more loans could be granted peasants there that are coming under the Ayacut; and more mechanica! equipment are transported place, so that levelling of the lands coming under the Ayacut could take place in the Tungabhadra area?

SHRI S. K. PATIL: As I said, question is under our examination and we have promised loans and we have given loans also actually to both the Governments concerned, so that it could be utilised for the purposes of giving small loans to these farmers.

Shri D. P. KARMARKAR: The investigation is being conducted by the police in a responsible manner.

Shri D. P. KARMARKAR: A case has been registered under section 304A, Indian Penal Code. My friend might not be knowing it. It says: "Whoever causes the death of any person by doing any rash or negligent act not amounting to culpable homi-

cide shall be punished with imprisonment of either description for a term which may extend to two years, or with fine or with both." My hon, friend might not be knowing it and he might put a supplementary as to what that section is.

Shrimati T. NALLAMUTHU RAMAMURTI: I am surprised, where is the need for investigation when it is obvious that a certain operation had taken place and a certain operation had been performed by a certain surgeon and the result of the operation had been this? Where is the need for investigation? It is so direct and explicit,

MR. CHAIRMAN: All these are allegations.

Shri D. P. KARMARKAR: I believe that he is a man of distinction, a competent surgeon, but still an allegation was made that an artery forceps was found in the abdomen of the deceased. Naturally, this matter has to be investigated to find out the possibility of the existence of the artery forceps at the time of the operation, and that is what the police are doing.

Shrimati YASHODA REDDY: May I know whether there are any other complaints of this kind, whether this is the first of its kind in Delhi or anywhere in India?

Shri D. P. KARMARKAR: I have not been able to hear of any other. Probably this is the first of its kind. I am not sure however.

Dr. R. P. DUBE: May I know whether this artery forceps being in the abdomen was the cause of the death?

Shri D. P. KARMARKAR: Sir, I have a report before me, but I should not like to share it with the House. But the whole matter is under investigation.

SHRIMATI BEDAVATI BURAGO-HAIN: May I know whether that instrument has been missing from the list of forceps?

SHRI D. P. KARMARKAR: That There also I should not like to say. is a report before me. No ment was missing. But I should not like to travel further into a matter in which police investigation is in progress.

SHRI AMOLAKH CHAND: May I know when the enquiry or investigation is likely to be finished?

SHRI D. P. KARMARKAR: matter is before the police. Naturally, in a case of this kind I am quite sure that the police will try their best to investigate as early as possible.

SHRI AMOLAKH CHAND: Will the hon. Minister try to enquire when the enquiry is likely to be completed?

SHRI D. P. KARMARKAR: I shall try to make an enquiry and tell the House about it.

SHRIMATI MAYA DEVI CHETTRY: May I know whether it is a Government hospital or a private dispensary?

SHRI D. P. KARMARKAR: It is a hospital under Government administration of the Delhi Administration.

DR. R. B. GOUR: Sir, on a point of The hon. Minister has taken the name of the doctor when whole matter is under investigation. When his name is published Press, it would have a certain effect on the reputation of the doctor concerned. When the matter is under investigation, he has no business to take the name of the doctor.

Mr. CHAIRMAN: Members no business to ask these questions about the name of the doctor.
