2. The offices mentioned at items (3), (4), (5) and (12) have to be shifted out of Delhi and Madras where they are at present located. The main difficulty in shifting the offices to the Circles concerned is lack of suitable office accommodation, and secondly, non-availability of suitable number of volunteers who would like to go to the new place.

The Postmaster-General, Bombay, has intimated that no office accommodation is available at Baroda and that none is expected to be available even after inviting tenders.

The question of shifting T. R. A. O. (Central) which is dealing with part of the Bombay Circle and Rajasthan Circle has been kept pending a decision on the question of realignment of existing Postal Circles with State boundaries.

As regards shifting of T.R.A.O. (North), attempts to secure office accommodation were made at Patiala and Nabha but without any success. Steps are now being taken to ascertain, if suitable office accommodation can be had at Jullundur.

The Director, Posts and Telegraphs, Hyderabad, has been asked to invite open tenders for securing office accommodation at Hyderabad.

PROPOSAL OF THE INDIAN AIRLINES COR-PORATION FOR INCREASING THE FARES

\*128. SHRI H. V. TRIPATHI: Will the Minister of Transport and Com-

munications be pleased to refer to the reply given to Starred Question No. 511, in the Rajya Sabha, on the 18th December, 1957 and state:

- (a) whether Government have since examined the proposal of the Indian Airlines Corporation for increasing the fares; and
- (b) what is the rate of increase, and what is the estimated increase in the income of the Corporation thereby?

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI HUMAYUN KABIR): (a) The proposals made by the Indian Airlines Corporation for the revision of passenger fares are under examination.

(b) The proposals are for revision rather than for increase of passenger fares and envisage increase in 106 sectors and decrease in 18 sectors, with  $n_0$  change in the remaining 49 sectors, out of the total of 173 sectors. The estimated additional revenue is approximately Rs. 33 lakhs per annum.

OPENING OF BROAD-GAUGE LINE BETWEEN INDORE AND UJJAIN FOR TRAFFIC

\*129. SHRI V. S. SARWATE: Will the Minister of RAILWAYS be pleased to state the time by when the broadgauge line between Indore and Ujjain, via Dewas which is now under construction would be opened for goods and passenger traffic?
