- (b) The price of this bi-lingual machine is not known but is likely to be approximately Rs. 7,000. No comparison can reasonably be drawn with the machines already in use which are all uni-lingual. As regards ^capacity, the machine is designed -on 3-shift 6-unit code basis with a maximum theoretical speed of about w.p.m. as against about 67 w.p.m. the uni-lingual machines which are based on 2-shift 5-unit code.
- (c) The decision is dependent on the findings of the experiments and •examination.]

#### DRAINAGE OF NAJAFGARH JHEEL

- •243. MOULANA M. FARUQI: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether Government have approved any scheme for the drainage of the Najafgarh Jheel this year; and
- (b) if so, what is the cost of the scheme; and how this cost will be met?

THE DEPUTY MINISTER OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) Yes. Sir.

(b) Estimated cost is Rs. 4:00 lakhs. Out of this 75% of the expenditure will be recovered from the beneficiaries and the balance 25% will be met by Government.

SHRI A. M. THOMAS: The scheme is to reclaim 1,600 acres which will be fit for *rabi* cultivation. The scheme envisages additional production of 800 tons of foodgrains and 29,000 tons of sugarcane. Rs. 4,00,000 has been sanctioned for the scheme out of which Rs. 3 lakhs will be treated as recoverable expenditure from the beneficiaries. The rest of the expense will be borne by the Centre as well as by the Punjab Government.

DR. RAGHUBIR SINH: To whom does the reclaimed land belong? Does it belong to Government or to some private party?

SHRI A. M. THOMAS: It is a lake. It is called the Najafgarh Jheel. It belongs to the Government.

*SAia* B. K. P. SINHA: On what basis will the land so reclaimed be allotted? To be more precise will it be run as a co-operative farm or alloted for private farming?

SHRI A. M. THOMAS: These details are being worked out. Sir, I am informed by my senior colleague that the land belongs to private parties.

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR): (a) to (d). A statement is laid on the Table of the Sabha.

### STATEMENT

It is true that there is delay in the submission of telephone trunk-call bills in some of the Telephone Revenue Accounting Offices. On 1-7-57 a sum of 43- 33 lakhs in respect of all bills issued upto 31-3-57 was outstanding. A substantial proportion of this relates to Government departments. No loss is considered to be sustained as a result of late issue of bills. The question of expediting the submission of bills and the collection of dues was considered in detail recently and steps have already been taken to improve the situation.
