export of green tea. It was sponsored by the Tea Board. This was a small delegation of four persons and did not require much expenditure. Good results may be expected from this delegation's visit.

DR RAGHUBIR SINH May I know the names of the schemes which were scheduled to be completed during the First Five Year Plan period?

SHRI S N MISHRA To give a complete list out of these so many dozens just now is difficult

DR. RAGHUBIR SINH: Was this not expected, Sir? This question related to the schemes formulated during the First and the Second Plans.

Shri S. N. MISHRA: We were asked, Sir, to indicate, in terms of this question, the schemes that have been undertaken and we have given the list of the schemes which run into dozens.

DR. RAGHUBIR SINH: What has been the response from the people in all these schemes?

Shri S. N. MISHRA: Obviously, Sir, the response, it seems, has been satisfactory. But the progress during the First Five Year Plan on the whole is not considered quite satisfactory.

DR. RAGHUBIR SINH: What is the cause of the unsatisfactoriness of the progress in the First Five Year Plan?

SHRI S. N. MISHRA: Mainly there were three or four reasons, firstly the late finalisation of the schemes, secondly, the transport difficulty between the main land and the various islands and thirdly the lack of technical personnel.

DR. RAGHUBIR SINH: What steps have been taken to get over these difficulties now?

SHRI S. N. MISHRA: In all these respects we are taking very active steps through the Ministry of Home Affairs.

Dr. RAGHUBIR SINH: May I know since when these active steps have been taken?

SHRI S. N. MISHRA: We are always at them.

SHRIMATI SAVITRY DEVI NIGAM: May I know the total amount of money spent under the various schemes during the first Five Year Plan period?

SHRI S. N. MISHRA: It was of the order of Rs. 86 lakhs.

SHRIMATI SAVITRY DEVI NIGAM: How much money was allotted for the whole Plan?

SHRI S. N. MISHRA: The first Five Year Plan outlay was of the order of Rs. 150 lakhs.
