- (a) whether the Planning Commission has called upon the State Governments to submit their proposals for Plan Programme for the year 1958-59 by the end of November, 1957;
- (b) if so, whether all the StateGovernments have submitted their proposals; and
- (c) what is the schedule fixed for the finalisation of the Plan Programme for the year 1958-59?

THE DEPUTY MINISTER OF PLANNING (SHRI S. N. MISHRA):
(a) Yes. Sir.

- (b) No. Sir,
- (c) Discussions with the States should conclude by the end of January 1958. The Annual Budgets for 1958-59 will include the agreed provisions for the various programmes.

Shri A. V. KUNHAMBU: May I know, Sir, whether in calling upon the State Governments to submit their proposals for 1958-59 the Planning Commission have given any indication regarding the so called pruning or rephasing aspect of the Plan?

SHRI S. N. MISHRA: No, Sir, we have indicated to the State Governments certain essential conditions. They number about seven. It would take a lot of time to give them. But broadly speaking, I may state that they have been asked to go slow on schemes which involve foreign exchange; to give priority to schemes which contribute to greater agricultural production and which also lead to the utilisation of the capacities created by irrigation projects. It has also been suggested to them on the basis of the suggestion made in the Standing Committee of the National Development Council that the order of the outlay for 1958-59 should be of the same level as for 1957-58.

Shri A. V. KUNHAMBU: May I know, Sir, if the Planning Commission for the Government of India suggested to the State Governments the possibility of giving emphasis on any particular aspect like food production or resettlement of landless labourers—in formulating their proposals?

Shri S. N. MISHRA: No such indication for the landless has been given, particularly in this context, but probably the hon. Member has in his mind the suggestion made in the Standing Committee of the National Development Council. In this particular context, however we have not laid any specific condition.

SHRI A. V. KUNHAMBU: May I know, Sir, whether the State Governments have given any indication regarding foreign exchange availability in the State sector of the Pian?

SHRI S. N. MISHRA: All those things will be considered during the course of the discussion that we are

going to have with the State Governments.

DEVELOPMENT OF INDUSTRIES IN JAMMU AND KASHMIR STATE UNDER THE SECOND FIVE YEAR PLAN

\*289. Moulana M. FARUQI: Will the Minister of Commerce and Indus-TRY be pleased to state:

- (a) the amount of money spent in Jammu and Kashmir State on the execution of the schemes for developing the State's industries under the Second Five Year Plan in the year 1956-57 and so far in 1957-58; and
- (b) how many medium and small industries have been set up under these schemes?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) and (b). The Second Five Year Plan of Jammy and Kashmir State provides for amount of Rs. 341 lakhs the development of Industries the State. Out of this Rs. 54 lakhs  $ar_{e}$ provided for the development of the following large and medium scale industries:

- (i) Government Woollen Mill
- (ii) Silk Weaving Plant
- (iii) State Finance Corporation
- (iv) Drug Manufacture
- (v) Cement.

So far Rs. 2.15 lakhs have been spent on these schemes. The details of these schemes are now under examination.

For the development of Village and Small Scale Industries, the following grants and loans have been made to the State:
