contractor. The contractor has been warned."

SHRI MAHESWAR NAUs.: May 1 Know, Sir, whether the Government are proposing to enforce the safety measures effectively in future?

SARDAR SWARAN SINGH: I venture to submit to that effect.

AYURVEDIC HOSPITAL AND CLINIC FOR TESTING AYURVEDIC MEDICINES

*306. SHRI P. C. BHANJ DEO: Will the Minister of HEALTH be pleased to state whether Government propose to set up an Ayurvedic Hospital and Clinic for the purpose of testing Ayurvedic medicines?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): No. Sir. There is, however, a Central Institute of Research in Indigenous Systems of Medicine at Jamnagar where certain Ayurvedic medicines are tested with reference to the specific diseases which are taken up for research.

LADY HARDINGE MEDICAL COLLEGE, NEW DELHI

THE MINISTER OP HEALTH (SHRI D. P. KARMARKAR): (a) The Government have decided to continue the Lady Hardinge Medical College as at present, but they are not committed to continuing it as an exclusively women's institution.

- (c) Six.
- (d) 59 out of whom 7 are male teachers.
- (e) Two.

PRODUCTION OF FOODGRAINS IN COM-MUNITY DEVELOPMENT AREAS

*320. SHRI DEOKINANDAN NARA-YAN: Will the Minister of FOOD AND AGRICULTURE be pleased to state what particular steps Government have taken to produce more foodgrains in the community development areas during the current year?

THE MINISTER OF FOOD AND AGRI-CULTURE (SHRI A.. P. JAIN): Some of the concrete measures taken in the community development areas are (i) effective supervision by the officers of the State Government over the Block staff for the planning, execution and evaluation of the agricultural programmes, preparation of cropwise targets of production for each of the Blocks and villages in the Blocks; (ii) concentration of the resources of agricultural department like seeds, fertilisers, plant protection materials and crop production campaigns; (iii) encouragement of peoples' participation through village co-operative and pan-ehayats in the drawing up and implementation of the crop-wise plans; (iv) setting up of seed multiplication farms with emphasis on the percentage of area covered with improved seeds; and (v) larger and better utilisation of local manurial resources by appointment of special staff.

PURCHASE OF RICE AND MILLETS

- *321. SHRI DEOKINANDAN NARA-YAN: Will the Minister of FOOD AND AGRICULTURE be pleased to refer to the reply given to Unstarred Question No. 986 in the Rajya Sabha on the 5th September, 1957 and state:
- (a) whether Government are making any purchases of rice and millets at present; and
- (b) if so, the extent of such purchases made so far and the names of the States from which and the rates at which the purchases have been made?

THE MINISTER OF FOOD AND AGRI-CULTURE (SHRI A. P. JAIN): (a) Government are at present making I purchases of rice, but not of millets. (b) A statement giving the details is laid on the Table of the Sabha. [See Appendix XIX, Annexure No. 39.]

STUDY OF AGRICULTURAL EXTENSION POLICY BY OFFICERS FROM ASIAN AND FAR EASTERN COUNTRIES

*322. SHRI V. K. DHAGE: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

- (a) whether it is a fact that Government have invited a group of senior officers from various Asian and Far Eastern countries to tour India in or about the month of December, 1957 to study agricultural extension policy and administration in the country; and
- (b) if so, the names of the countries from which these officers hail and the places they will visit?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) At the request of the Food and Agriculture Organisation of the United Nations, the Government of India along with the Governments of Japan and Philippines agreed to serve as host countries for the agricultural extension study tour.

(b) The countries and territories in the Asian and Far Eastern Region which are represented on this Group are Burma, China (Formosa), India, Japan, South Korea, Malaya, Philippines, Thailand, Hongkong, Sarawak, North Borneo and Viet Nam. This Group is coming to India after visiting Japan and Philippines. In India the tour will cover visits to Extension Blocks, Extension Training Centres and places of general agricultural interests in and near Lucknow in Uttar Pradesh and Delhi.
