The decision of the majority, however, was that the General Conference should not consider, during the year 1957, any proposals to exclude the delegate of the Republic of China (Formosa) or to seat a delegate from the People's Republic of China and also that it should take no decision regarding the credentials submitted on behalf of the delegate of Hungary.]

SHRIMATI LAKSHMI MENON: Sir, I have got the whole speech of our representative to the Conference. Do you want me to read it out, Sir? The question here is concerned only with the admission of the People's Republic of China and the Republic of China (Formosa). I have already stated the decision. We are always for the universality of membership in these Conferences. Since the majority opinion was that these two questions should not be considered by the Assembly the majority vote was against their consideration.

(b) During the current year centres will be opened at 8 Employment Exchanges viz., Delhi, Calcutta, Bombay, Madras, Lucknow, Ambala, Patna and Hyderabad and thereafter at 15 Exchanges each year during the Second Plan according to present programme.]
