#### INDIAN FILM FESTIVAL IN LONDON

♦8. SHRI TAJAMUL HUSAIN (ON BEHALF OF SHRI M. VALIULLA): Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether a Grand Premiere of the Indian Film Festival was held in London recently by the Asian Film Society;

(b) which film was selected for the first day of the Festival; and

(c) how the exhibition of this film was received by the audience?

THE PARLIAMENTARY SECRETARY TO THE MINISTER OF INFORMATION AND BROADCASTING (SHRI G. RAJAGOPALAN): (a) to (c). The Asian Film Society of London is a private organisation with which Government of India have no concern. In September last this Society organised a festival of Indian films. The

feature films for participation in the festival were selected by the Society themselves. Our High Commissioner in London, however, supplied five Government of India documentaries for exhibition in the festival. According to Press reports, the feature film 'Pyaasa' was exhibited first. Government of India have no information about the audience reactions beyond what has been published in the newspapers.

SHRI TAJAMUL HUSAIN: What was the duration of the Festival? How long did it last?

DR. B. V. KESKAR: Sir, it has been said in the answer that this was organised by a private *society* and Government have not got much detailed information about this.

SHRI TAJAMUL HUSAIN: Was the admission by ticket? If so, to whom were the proceeds earmarked?

SHRI G. RAJAGOPALAN: The proceeds go to the private society. It has nothing to do with Government.

MR. CHAIRMAN: Questions are over.

#### WRITTEN ANSWERS TO QUESTIONS

##### PRIME MINISTER'S VISIT TO JAPAN

\*16. SHRI V. VENKATARAMANA: Will the PRIME MINISTER be pleased to state:

(a) whether he had visited any farms in Japan during his recent visit; and

(b) if so, what are his reactions about the production and cost of production etc. in small farms *vis-a-vis* large-sized farms?

THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): (a) and (b). In the course of his tour, the Prime Minister visited two farm houses. One was a medium-sized one and the

other was a somewhat larger one. It was not possible for him to make a study about the production or the cost of production. The farmers appeared to be prosperous.

#### IMPORT AND PRICE OF CEMENT

•19. SHRI N. RAMAKRISHNA IYER: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) the extent to which the present Import restriction has affected the quantum of import of cement;

(b) whether Government propose to reduce the delivered price of cement to the consumer as a consequence of lesser import; and

(c) whether Government propose to revise the Plan target for cement production to a more reasonable proportion?

TH\* MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH) : (a) Except for imports against outstanding commitments, no fresh imports involving foreign exchange are made.

(b) No, Sir.

#### COMPLAINTS FROM ANDHRA ASSOCIATIONS IN BURMA REGARDING TELUGU BROADCASTS IN THE EXTERNAL SERVICES OF A.I.R.

\*28. SHRI V. PRASAD RAO: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether Government have received any complaints from Andhra Associations in Burma regarding the inadequacy of Telugu coverage in the external services broadcasts from the All India Radio; and

(b) if so, what action has been taken thereon?

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KESKAR): (a) and (b). A representation has been received from Andhra Associations in Burma for starting a

Telugu service in the external broadcasts.

At present the only services that are being broadcast for Indians overseas are in Tamil, Gujarati and Hindi. In view of the high costs for starting any new service, it is not possible to take up any proposal for additional language broadcasts in our external services.
