(b) The F.A.O. Conference meets once in two years to consider agricultural problems from the global point of view, such as reviewing the world food and agricultural situation, and to examine the programme of activities and the budget of the Organisation for the next *biennium* and other administrative and financial matters arising from the day-to-day working of the Organisation. The questions discussed were thus of general interest to all the member-countries, and no specific recommendations relating to any individual member-country were made.
