given to co-operative societies is sufficient for the looms that are working under the cooperative societies for the whole year?

SHRI N. KANUNGO: Yes, Sir. There is no shortage in the availability of yarn and cooperative societies can get as much as they like.

SHRI DEOKINANDAN NARAYAN: May I know, Sir, if it is a fact that these looms are not working on account of inadequate supply of yarn for the whole year and even for the whole month?

SHRI N. KANUNGO: Yes, sometimes it depends upon the demands and sales and the working capital position and various other factors.

- (a) the number of circles, divisions and sub-divisions of Public Works Department in Himachal Pradesh;
- (b) whether these divisions are fully equipped with staff especially overseers:
- (c) whether it is a fact that many overseers employea by the Department have given up their jobs, if so, for what reasons;
- (d) whether it is also a fact that many overseers are being employed in Himachal Pradesh on work-charged basis, if so what is the present number of such overseers?

THE DEPUTY MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI ANIL K. CHANDA): (a) 3 Circles, 14 Divisions and 60 Sub-divisions.

- (b) The divisions are fully staffed down to the level of Assistant Engineers. In respect of Overseers the P.W.D. is at present short of 44 Overseers out of a total requirement at 308.
- (c) About 30 Overseers have resigned in recent months. They did not assign any reasons.
  - (d) Yes, Sir. 52.
