Government of India have taken all possible steps to facilitate matters so far as Customs formalities etc., are concerned.

Has that fact been brought to the notice of the Central Board of Revenue so that customs restrictions which should never be applied to gifts may be passed over in these cases and the long delays which, I understand, have taken place will be eliminated in future?

DR. K. L. SHRIMALI; This matter was brought to my notice only a few days back by the hon. Member and this is a matter in which only the Cabinet can take a decision whether all these articles which are imported could be imported without customs duties. I will get the matter further examined

DR. RAGHUBIR SINH: May I know whether no other institution ever brought this matter to the notice of the Ministry?

DR. K. L. SHRIMALI: It is very difficult for me to say. The hon. Member is asking a vague question.

Dr. RAGHUBIR SINH: the Ministry not aware that this is a gift and should it not have taken the initiative on its own?

DR. K. L. SHRIMALI: They ar& not treated as gifts.
