The question of granting a further loan for meeting the expenditure on water mains to be laid by the Joint Water and Sewage Board is under consideration.

SHRI M. VALIULLA: In addition to the amount given, has any further amount been asked for either as loan or as grant? In regard to the amounts already sanctioned, I want to know whether they have been given as loans or as grants.

SHRI D. P. KARMARKAR: That is more than I can say at the moment. I shall try to find this out. I find for instance, that a loan of Rs. 80,000 has been given to the West Delhi Municipal Committee for the provision of amenities in the villages.

SHRI M. VALIULLA: Is it meant mostly for the refugees or are there other people also residing in those areas?

SHRI D. P. KARMARKAR: Subject to correction, I should say that this has been given to amount W.D.M.C. because a large number of the people living there are refugees but for the precise number of nonreragees, I should like to have notice.

Dr. P. C. MITRA: Since when has this Committee been functioning?

SHRI D. P. KARMARKAR: At the moment, I have not got the historical and chronological data before me.

Dr. P. C. MITRA: Why has Committee been indifferent so far in regard to these vital matters?

Mr. CHAIRMAN: He does not know when it was started. It has not been indifferent.

†[EXPORT OF FROZEN FROGS

\*365. Shri NAWAB SINGH CHAU-HAN: Will the Minister of Food and AGRICULTURE be pleased to state:

- (a) whether the fish farmers of the former State of Travancore-Cochin are exporting frozen frogs; and
- (b) if so, to which countries, what quantity and at what rates?]

THE DEPUTY MINISTER OF AGRI-CULTURE (SHRI M. V. KRISHNAPPA): (a) No. Fish farmers are not exporting frozen frogs. Frog meat is frozen by a few private companies in Kerala and exported.

(b) about 125 tons of frog meat was exported to U.S.A. during the period from September, 1956 to July, 1957. The prices range between Rs. 3.81 and Rs. 4.76 per pound.

Mr. CHAIRMAN: He does not know the distinction.
