THE DEPUTY MINISTER OF IRRI-GATION AND POWER (SHRI J. S. L. HATHI): (a) Yes, Sir.

- (b) Six months, upto the end of December, 1957. The training given at the Centre will enable the Fisheries Officers of the State Governments to undertake construction of new designs of small power fishing boats.
- (c) Ten trainees are undergoing training at present at the Centre. The expenses of nine trainees from State Governments are to be borne by the State Governments concerned and that

of the trainee from Buganda Government by that Government.

(d) The trainees should be State Government nominees of the Fisheries Department of the States concerned and should have experience in fishing craft and tackle used in the respective States. Some technical background in fisheries is also desirable.

DR. RAGHUBIR SINH: May I know from which States these candidates have come?

SHRI M. V. KRISHNAPPA: West Bengal 1, Orissa 1, Madras 2, Kerala 2, Mysore 2 and Bombay 1.

Dr. RAGHUBIR SINH: May I know whether there is going to be another course after the first is over?

SHRI M. V. KRISHNAPPA: will decide at the end of the course because one F.A.O. Technical expert Mr. Paul Zeinar is now training them and it will depend upon the duration of his stay.

- (a) whether Government are aware that an explosion occurred on 21st August, 1957 of a wagon loaded with crackers in the Yard of Katpadi Junction in the Southern Railway;
- (b) if so, the cause of such an explosion:
- (c) the number of lives lost and other casualties, the quantity of material lost and the amount of loss to the Railway; and
- (d) what steps do Government propose to take to prevent recurrence of such an accident?

THE DEPUTY MINISTER OF RAIL-WAYS (SHRI SHAH NAWAZ KHAN): (a) Yes.

- (b) The matter is under investigation.
 - (c) 8 killed and 9 injured.

(d) Booking of fire-works has been stopped on all the railways until further orders.

Further steps, as required, will be taken in the light of the results of the enquiries into the cause of the accidents at Katpadi and Asansol which are in progress.

SHRI P. S. RAJAGOPAL NAIDU: May I know the value of the consignments that are now held up owing to this ban now imposed?

SHRI SHAH NAWAZ KHAN: We do not have information on that.

SHRI P S. RAJAGOPAL: NAIDU: May I know whether it is the intention of the Government to insist on the compulsory insurance against third party risks instead of detaining the wagons which are now loaded with crackers?

SHRI SHAH NAWAZ KHAN: Τŕ may be considered Sir.

SHRI P. S. RAJAGOPAL NAIDU: May I know, Sir, whether it has reached the notice of Government that this explosion had been caused by the rough handling by the persons who are responsible for the transhipment from metre-gauge to broad gauge at Katpadi junction?

SHRI JAGJIVAN RAM: Sir, the whole matter is now under investigation and it is premature to say what was the cause of the explosion.

SHRI P. S. RAJAGOPAL NAIDU: May I know, Sir, whether any interim compensation has been paid to the dependants of those who lost their lives in this explosion?

SHRI SHAH NAWAZ KHAN: No Sir, not yet.

Dr. RAGHUBIR SINH: May I know. Sir, whether this is the first explosion of its kind?

SHRI JAGJIVAN RAM: This is the second.

SHRI B. K. P. SINHA: Will insurance make the explosives not explodable?

(No answer.)

Mr. CHAIRMAN: Mr. Chaman Lall. you wanted to put a question.

DEWAN CHAMAN LALL: That was about payment of compensation and it has already been put. But if I may follow up that question: May I know why no steps have been taken to provide compensation for those who were killed, I mean to the families of those killed in this explosion?

SHRI SHAH NAWAZ KHAN: Compensation will be paid in accordance with the Workmen's Compensation Act or the provisions of the Accidents Act and for that certain enquiries have to be made. As soon as that is completed, it will be paid.

SHRI V. K. DHAGE: Will Government place on the Table of the House the report of the investigation with regard to this explosion?

SHRI JAGJIVAN RAM: I will consider that.
