SHRI KISHEN CHAND In many cases delay has changed the situations and then their have been alterations in the treaties May I know what steps are being taken by our Government to see that there is no extraordinary delay in the completion of this treaty? The world situation may change and there may be alterations thereby

SHRI JAWAHARLAL NEHRU The hon Member has not followed my first answer to the question which is an adequate answer to the subsequent question

SHRI P C BHANJ DEO May I know, Sir, if it is a fact that the French Government still holds out in the hope that if the Hague Court's opinion about the claims on Goa goes against India they too will be able to claim a right of passage back to their territory?

MR CHAIRMAN No insight into their mind

SHRI JAWAHARLAL NEHRU The hon Member speaks of the right of passage Right of passage from where to where?

SHRI P C BHANJ DEO The Portuguese have claimed right of passage to India

SHRI JAWAHARLAL NEHRU Anybody has free passage all over India

SHRI P C BHANJ DEO in regard to Nagar-Haveli

MR CHAIRMAN If the question of Goa is decided against India will it encourage the French People to hold on? That is what he means

THE DEPUTY MINISTER OF LABOUR (SHRI ABID ALI) Yes two Work and Orientation Centres, one each at Kalamassery in Kerala and Delhi have started functioning A third Centre has been sanctioned in Kalyani West Bengal Two small scale production Centres, one at Thiruvella and the other at Ettumanur in Kerala were sanctioned during 1956-57 15 more such Centres are proposed to be set up during 1957-58 A draft Scheme for the

establishment of Goods Transport Co-operatives has been circulated to the State Governments for their views.

SHRI SONUSING DHANSING PATIL: Is the Government aware that the growing unemployment among the educated persons may lead them to fall an easy prey to communism?

(No reply.)

SHRI B. K. MUKERJEE: May I know if the Government keeps separate statistics of educated unemployed and uneducated unemployed, and if they maintain separate statistics for educated unemployed may I know what is the percentage among them who are technically trained and those who are non-technical people?

SHRI ABID ALI: On the basis of the registration at the Employment Exchanges we collect the statistics, and these are placed here from time to time, Sir.

SHRIMATI SAVITRY DEVI NIGAM: May I know if the Government has accepted the Bharat Sevak Samaj's slum sena scheme according to which a large number of unemployed educated persons will be drawn in as social workers?

SHRI ABID ALI: The Bharat Sevak Samaj is co-operating in this scheme. With regard to the particular scheme, I require notice.

SHRIMATI YASHODA REDDY: May I know, Sir, apart from the study groups conducted on educated unemployment, has any survey on a scientific basis been conducted on the extent and nature of educated unemployment?

SHRI ABID ALI: That is what I have replied earlier. . . .

MR. CHAIRMAN: On a very scientific basis we are having the survey.

SHRI ABID ALI: . . . on the basis of information obtained through the employment exchanges.

DR. SHRIMATI SEETA PARNAND: The hon. Minister has said that in 1957-58, 15 more centres might be started and it is September now. How many of these centres have already been started?

SHRI ABID ALI: I have given the names of the centres already started. With regard to the other centres, we shall persuade the State Governments to hurry up with them.

SHRI N. C. SEKHAR: May I know the number of skilled employees among the retrenched people?

SHRI ABID ALI: We are not yet at question No. 464.

SHRI B. K. MUKERJEE: May I know, Sir, if any serious attempt is being made by the Government to insist on the employers to requisition their requirements through the employment exchanges alone and not to resort to recruitment through their own machinery?

SHRI ABID ALI: Persuasion as much as it is possible.

SHRIMATI SAVITRY DEVI NIGAM: May I know, Sir, if it is a fact that these camps have been very successful and already a number of trainees have been employed suitably in various industries?

SHRI ABID ALI: Yes, Sir. It is true.

(b) how many of them have so far been placed in employment; and

(b) 5,112.

(c) The work in respect of ex-employees of Defence Installations has been practically completed. Regarding River Valley Projects, retrenchment is a continuing process.
