#### AMOUNT DUE ON ACCOUNT OF PURCHASE OF CHEMICAL FERTILIZERS

982. SHR. M. VALIULLA: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) what was the amount due on the 31st March, 1957 from the State Governments on account of the purchase of chemical fertilizers; and

(b) whether any private firms also owed any money to Government on this account and if so, how much each firm had to pay on that date?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN):

(a) Rs. 4,77,74,852, which is approximately 23 per cent, of the total debits raised.

(b) No, Sir; as the cost of the fertilisers is always recovered from private firms in advance of supply.

#### SUPPLY OF FOODGRAINS TO WEST BENGAL, MADRAS, MYSORE AND KERALA

(a) the quantity of foodgrains supplied to West Bengal, Madras, Mysore and Kerala from 1st April, 1957; and

(b) what was the quantity of foodgrains asked for by each of these States?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) The following table indicates supplies during the period 1st April to 24th August, 1957.
