

The works are sanctioned on a priority basis every year keeping in view the funds available, targets laid down and the latest trends of traffic. In sanctioning works priority is given to the freight traffic, particularly pertaining to coal, steel and cement industries.

#### **ELECTRIFICATION OF RAILWAY LINES**

1028. SHRI M. VALIULLA: Will the Minister of RAILWAYS be pleased to state whether Government propose to cut down electrification of certain rail way lines due to foreign exchange difficulties; and if so, which are those lines?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN) : Electrification will be processed according to the foreign exchange position from time to time, and nothing has been cut down so far.

#### **OPERATION OF DIESEL ENGINES IN COAL-BEARING AREAS**

1029. SHRI M. VALIULLA: Will the Minister of RAILWAYS be pleased to state whether any diesel engines are in operation in coal-bearing areas; and if so, how many?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN) : No.

#### **'PROVED' AREA FOR OPERATING TUBE-WELLS**

1030. SHRI M. VALIULLA: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(b) which are the 'proved' areas for operating tube-wells in India; and

(b) on what basis a 'proved' area is determined?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) Areas lying in the Indo-Gangetic

Plain in the States of Punjab, Uttar Pradesh and Bihar and some tracts in the North Gujarat Area of the Bombay State are considered as 'proved' areas for purposes of constructing large-sized tubewells for irrigation.

(b) An area in respect of which the available geophysical and hydro-logical data, as well as previous experience of groundwater extraction, go to show that adequate supplies of groundwater at economic depths are available is considered as a 'proved' area. An untried area is, however, surveyed first geophysically as well as by drilling exploratory bores. Pumping tests on the bores and observations of groundwater tables, rainfall, run off etc. in the catchment area which provides recharge to the ground water storage, give the required scientific data for deciding whether the area is suitable for installation of tubewells for irrigation. The relevant scientific data in this regard is collected and interpreted by the Geological Survey of India.

#### **COMMUNITY PROJECTS IN REORGANISED MYSORE STATE**

1031. SHRI M. VALIULLA: Will the Minister of COMMUNITY DEVELOPMENT be pleased to state:

(a) the number of Community Projects that are working in the reorganised Mysore State;

(a) where they are working; and

(a) whether any new training centres are proposed to be opened shortly to meet the increasing requirements of trained Social Education Organisers; if so, when they will be opened; and

(b) what will be the strength of those new centres and how many of them will be for women?

THE MINISTER OF COMMUNITY DEVELOPMENT (SHRI S. K. DEY) : (a) Yes, Sir. Three. By December, 1957.

(b) 240. There will be no Centre exclusively meant for women. Men and Women Social Education Organisers will be trained together at these Centres.
