THE PARLIAMENTARY SECRETARY TO THE MINISTER OF INFORMATION AND BROADCASTING (SHRI G. RAJAGOPALAN): (a) and (b). Mr. Weeks, an expert from the U.SA., is training a number of our technicians in the Cartoon Section of the Films Division. All these cartoonists and artists are regular employees of Government and there is no question of their training being for a prescribed period.

- (c) Work on the first cartoon film has already been started and is expected to be completed by March, 1958.
- DR. RAGHUBIR SINH: May I know, Sir, how long this expert is going to stay in India?
- SHRI G. RAJAGOPALAN: The expert probably will stay on till the beginning of

DR. RAGHUBIR SINH: May I know, Sir, whether any Indian is particularly being trained to be an expert to take his place when he goes back after his assignment is over?

SHRI G. RAJAGOPALAN: At present in the Cartoon Section of the Films Division there are the Camera men, the directors, artists, etc., and they are all undergoing training under his guidance and they are already producing a cartoon picture. This is being produced by the Indian technicians and Indian artists in the Films Division under the supervision of the foreign expert.

SHRI G. RAJAGOPALAN: No emoluments are paid. His services have been obtained under the Indo-U.S. Technical Programme.

SHRI BHUPESH GUPTA: Having regard to the peculiar sense of humour of the Americans may I know what steps had been taken by the Government to see that such sense of humour does not creep into the films that are going to be produced here?

MR. DEPUTY CHAIRMAN: Order, order.

SHRI MAHESWAR NAIK: May I know, Sir, to what extent these cartoon films are in demand by the private cinema houses?

DR. B. V. KESHAR: Cartoon films are very much in demand. More especially it is considered to be a very important film medium for the juveniles and it is for that reason and with that objective that we are trying to develop it.

SHRI BHUPESH GUPTA: It is for this reason I wanted the clarification.

(b) The Indian version of the film has not yet been received after final processing for release in India. A Russian version is understood to have been released in the USSR

- SHRI T. S. PATTABIRAMAN: May I know, Sir, what is the name of the film? What is its length?
- SHRI G. RAJAGOPALAN: The name of the film is 'Dawn over India'. It will be about 8000-9000 feet.
- SHRI T. S. PATTABIRAMAN: What is the investment of the Government of India in this?
- RAJAGOPALAN: SHRI G. The Government of India have not made any investment as such, Sir. The expenses of the Russian technicians when in India are borne by the Government and we have provided for an estimate of Rs. 2 lakhs for overall expenses for this thing.
- SHRI T. S. PATTABIRAMAN: May I know, Sir, why there has been inordinate delay in the release of the picture here?
- SHRI G. RAJAGOPALAN: There was no inordinate delay as such. It has gone to Russia for processing and after the finally processed copy is ready then only we can release it for public exhibition here.
- SHRI T. S. PATTABIRAMAN: May I know what are the terms of the contract and who controls the right of distribution in India, in the U.S.S.R, and other parts of the world?
- DR. B. V. KESKAR: The film is the result of a general discussion between the Government of U.S.S.R, and India who were desirous of contributing something for showing the development and evolution that India has had during the last fifty years or so and it was decided generally—I am giving the rough outline of the agreement-that the technical know-how would be provided by Russia who will give their best film experts and we

will provide a number of technicians to go around the country with them and the film has been prepared on that basis. In its context and everything the film has been prepared in complete agreement between both the Governments.

- SHRI M. H. SAMUEL: Is it a fact that the same film was shown to select audiences here some months back and is it that the delay is due to some policy matters?
- DR. B. V. KESKAR: The first rough draft was shown here in the Russian Embassy and as I said, the Indian version of it is still under preparation and we hope to get it soon.
- SHRI T. S. PATTABIRAMAN: May I know who wrote the script and whether it had the approval of the Film Censor Board?
- DR. B. V. KESKAR: There is no one particular person and as I said it has been prepared in collaboration. Our script writers were also in Moscow for a number of months and helped the Russians in preparing the script.
- DR. SHRIMATI SEETA PARMANAND: How long has this picture been under production and what is the expenditure involved so far?
- SHRI G. RAJAGOPALAN: We have already said that as far as the Government of India's portion of the expenditure is concerned, it would not exceed Rs. 2 lakhs. It is only to meet the expenses of Russian technicians, when in India and the picture has been in production for nearly a yaa» and a
- DR. RAGHUBIR SINH: May I know whether any advantage is going to be taken of the special processing system that is being followed in U.S.S.R, by making our technicians know about it?
- DR. B. V. KESKAR: When our technicians are there when the processing is taking place they will also
