FOODGRAINS REQUISITIONED

(b) which are the States from where foodgrains have been requisitioned; and

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN;: (a) 31,000 tons.

(b) Andhra Pradesh, Rajasthan and West Bengal.

(c) The prices so far fixed are: —

Rice:—Rs. 17 to Rs. 19/12 per maund for bagged rice in Andhra Pradesh. The prices in West Bengal have not yet been finalised.

Gram:—Rs. 10.62 to Rs. 10.87 per maund ex-godowns ofr naked gram.

INCONVENIENCE CAUSED TO RAILWAY PASSENGERS BY HAWKERS ON STATIONS

*576. SHRI B. K. MUKERJEE: Will the Minister of RAILWAYS be pleased to state:

(a) whether Government are aware that almost the entire space available at present on railway platforms ls occupied by hawkers and their trolleys etc. thereby preventing passengers from entraining or detraining;

(b) if so, what action Government propose to take in the matter; and

(c) whether the Railways provide any special facility to passengers to carry furniture and other commodities sold by hawkers at the railway platforms?

THE MINISTER OF RAILWAYS (SHRI JAGJIVAN RAM): (a) and (b). The number of hawkers and trolleys allowed to operate on station platforms is strictly limited with due regard to the need to ensure availability of adequate room for the free movement >of passengers ,and whenever congestion is noticed the number of hawkers and/or trolleys is reduced.

(c) Does not arise as articles such as furniture are not to be sold on platforms.
