Infiltration of Pakistani Nationals INTO INDIA

- *586. SHRI S. C. DEB: Will the Minister of Home Affairs be pleased to state:
- (a) whether it is a fact that contiued infiltration of Pakistani nationals ito India by the Assam border and ther borders is going on; and
- (b) what steps Government have taken to stop such infiltration?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): (a) Yes.

- (b) Extensive patrolling is done on the border areas by the police to check infiltration of Pakistani nationals into India. Suitable action is taken against. such Pakistani nationals if detected.
- SHRI S. C. DEB: May I know for how long such infiltration has been going on in this country and the total number of infiltrations in a year?

Mr. DEPUTY CHAIRMAN: Total number of?

SHRI S. C. DEB: Such infiltrations in a year.

SHRI B. N. DATAR: Such infiltration has gone down during the last few months. I have figures for the period 1st January to 30th April 1956. It was about 1,500 and this year for the same period it is 520.

SHRI S. C. DEB: May I know whether there are any special areas where large-scale infiltration is there?

SHRI B. N. DATAR: I am not aware of any.

EXCEEDING OF EXPENSE RATIO BY THE LIFE INSURANCE CORPORATION

DEPUTY THE MINISTER OF FINANCE (SHRI B. R. BHAGAT): The expense ratio of the Life Insurance Corporation will be known only after the accounts of the first financial period of the Corporation are completed.

*588. Shri P. N. RAJABHOJ: Will Minister \mathbf{of} EDUCATION Scientific Research be pleased to state whether Government propose to convert the Osmania University into a Hindi University; and, if so, at what stage is the proposal now?]

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION SCIENTIFIC RESEARCH (Dr. K. L. Shrimali): There is no proposal to convert Osmania University into Hindi University. However, the question of the reorganisation of the

Osmania University into a Centra: University with Hindi as the principal medium of instruction is being pursued with the State Government of Andhra Pradesh.

SHRI KISHEN CHAND: May I know from the hon. Minister whether the Committee that was appointed to enquire into the possibility of having Hindi as the medium has submitted its report and if so, what are its findings?

Dr. K. L. SHRIMALI: Not vet.

SHRI KISHEN CHAND: When is it likely to submit the report?

Dr. K. L. SHRIMALI: We have requested the Chief Minister of Andhra to let us have the agreement of his Government to the proposal first and then the Committee will start.

DR. W. S. BARLINGAY: Is it not true that there was a proposal that this University should be directly under the management of the Government of India?

Dr. K. L. SHRIMALI: Yes, Sir. That was the proposal and that proposal has been before the Government since 1951.
