EMPLOYEES WITHOUT THE KNOWLEDGE OF HINDI

*598. SHRI H. V. TRIPATHI: Will the Minister of HOME AFFAIRS be pleased to state the total number of employees of the Government of India who have no knowledge of Hindi?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): The information is being collected and will be laid on the Table of the House.

OIL EXPLORATION

*599. SHRI H. V. TRIPATHI: Will the Minister of STEEL, MINES AND FUEL be pleased to state:

(a) the names of the places where efforts have been made by Government for exploring oil since 1951;

(b) the amount of money spent by Government thereon; and

(c) the quantity of oil discovered as a result of those explorations?

THE MINISTER OF MINES AND OIL (SHRI K. D. MALAVIYA): (a) Since October, 1955, the Oil and Natural Gas Commission (formerly Directorate) has explored the following areas:—

Gogha, Cambay and Kutch in Bombay State; Hoshiarpur, Janauri Dharamsala, Bhal, Mandi and Jawalmukhi in the Punjab; Jaisalmer and Ramgarh in Rajasthan.

Under the Indo-Stanvac Project in which the Government of India have a 25 per cent. interest, the Standard Vacuum Oil Company explored certain areas in West Bengal and took up test drilling near Burdwan and Galsi.

(b) The total amount of expenditure incurred by the Oil and Natural Gas Commission is Rs. 133,97,927. The contribution of the Government of India to the Indo-Stanvac Project since conclusion of the Agreement in December 1953 is Rs. 1,08,78,836.
