(b) A statement showing the particulars of the Scientific apparatus provided to each Vigyan Mandir is attached. [See Appendix XVIII, Annexure No. 128.]

Ce) No list of the types of problems which are to be referred t{ the National Laboratories for investigation and advice has been formulated. Any problem which cannot be satisfactorily attended to in a Vigyan Mandir, is expected to be referred to the National Laboratory concerned, provided the problem is considered of sufficient importance.

(d) It is proposed to establish Vigyan Mandirs during the Second Five Year Plan only in rural areas, as far as possible.

SHRI AMOLAKH CHAND: May I know, Sir, what is the amount spent on a Vigyan Mandir and what is the literature supplied? And, Sir, will the hon. Minister be pleased to lay a set of the literature supplied there on the Table of the House?

DR. MONO MOHAN DAS: Sir, so far as the literature is concerned, I shall be very glad to do what the hon. Member has wished. And regarding the expenditure, I may inform the hon. Member, Sir, that so far as the non-recurring expenditure is concerned, it requires furniture worth Rs.. 4,400 and the operators, appliances and equipments worth Rs. 12,100. The total non-recurring expenditure comes to Rs. 16,500. Then regarding the recurring expenditure, it is Rs. 1,100 for chemicals, researches etc.; contingencies, travelling allowances etc. come to Rs. 2,400; and pay and allowances of the officers, that comes to Rs. 8,900. The total comes to Rs. 12,400.

SHRI M,. VALIULLA: How many Vigyan Mandirs are going to be established in the Second Five Year Plan? period?

DR. MONO MOHAN DAS: Originally Sir, we had a proposal to establish 92 Vigyan Mandirs all over India for

which Rs. 50 lakhs were earmarked. But due to the financial difficulties of our Government, we do not think we shall be able to achieve that target.

PANDIT S. S. N. TANKHA: May I know what is the purpose of these Vigyan Mandirs?

DR. MONO MOHAN DAS: These Vigyan Mandirs are being established to carry scientific information to the rural areas, and also to make the masses scientific-minded.

MR. DEPUTY CHAIRMAN: By the Government of India.

SHRI B. N. DATAR: So far as the first six persons are concerned, the pensions were granted by the British Government. So far as the last two are concerned, they are being granted from this year by the present Government.

(b) The Committee finalised the Questionnaire, which is to be circulated amongst State Governments, Universities and prominent persons connected with libraries and the procedure which it would adopt in its work.

SHRI M. VALIULLA: Is it not a fact that this Committee was set up in pursuance of the recommendations made by the Library Seminar in 1955?
