## GOVERNMENT EMPLOYEES CHARGED FOR BRIBERY

128. SHRI DEOKINANDAN NARAYAN: Will the Minister of HOME AFFAIRS be pleased to state the number of employees of the Central Government who were charged departmentally or prosecuted in courts for bribery during the year 1956-57 and results thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): During the year 1956-57 the Special Police Establishment prosecuted in courts 195 officers for corruption of which the charge against 46 could be clearly classified as bribery.. Of the 195 officers, 24 were convicted, 18 acquitted and 153 are still under trial. During the same period corruption cases against 345 officers were reported by the Special Police Establishment for departmental action of which 60 were charged clearly for bribery. Of the 345 officers, 41 were punished, 25 exonerated while the cases against 4 were disposed of otherwise. The enquiry is still in progress against the remaining 295 officers.
