#### STATEMENT

Steps taken to increase the Production and Export of Leechi

*Production.*—(a) In order to increase the production of leechies the Government of U.P. have taken steps to cultivate this fruit in the lower valley districts of Tehri-Garhwal in addition to the production available in the Dehra Dun District of the State.

(b) As there was a good demand for dehydrated leechies in the U.S.A. the Ministry of Food and Agriculture had requested the Governments of U.P. and Bihar to explore possibilities of dehydration of this fruit. A scheme has been prepared by the Directorate of Marketing and Inspection of the Ministry of Food and Agriculture to set up a pilot plant for dehydration of leechies at Saharanpur Fruit Research Station in the U.P. A similar offer has also been made by the Ministry of Food and Agriculture to the Government of Bihar for installing a pilot plant for the dehydration of leechies in that State.

*Export.*—In order to develop markets in foreign countries for Indian leechies we had asked our Commercial Representatives in the U.S.A. and certain European countries such as U.K., West Germany, France, Sweden, Switzerland, etc., to explore possibilities of marketing this fruit in those countries. Samples of dehydrated leechies were also sent to these Missions by the Government of U.P. In response to this, information was received from our Commercial representative in Switzerland that importers in that country were more interested in the leechies in syrup and not in a dehydrated form.]

THE MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI K. C. REDDY): (a) A representation from the Tenants' Welfare Association, Kotla Mubarakpur, has been received by the Government.

(b) and (c). So far as this Ministry is concerned, the representation contains suggestions for relief in the matter of ejection of tenants and control of rents. The matter is under active consideration of the Government.
