#### OPERATION OF JET AIRCRAFT IN INDIA

\*149. **SHRI M. VALIULLA:** Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:

(a) the names of the places in India where jet aircraft are likely to operate; and

(b) whether there is any proper and adequate runways at all those places?

**THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI HUMAYUN KABIR):** (a) According to present plans, the jet aircraft to be acquired by the Air-India International Corporation are likely to operate from Bombay.

(b) The runway at Santa Cruz will need to be developed for jet operations. The question of developing one or more alternative aerodromes is under consideration.

**SHRI M. VALIULLA:** Is it not a fact that at Palam also American jet aircraft will be coming and that here also the runway will have to be extended?

**SHRI HUMAYUN KABIR:** As I have said, a proposal for developing alternative aerodromes is under consideration. At present we have no information about any American jet planes coming to Palam.

**SHRI M. VALIULLA:** Have we not placed orders for American Boeing jet aircraft?

**SHRI HUMAYUN KABIR:** I have already said, Sir, that our Boeing planes will operate from Bombay. That is the present plan.
