(ग) फर्माइश प्राप्त होने के पश्चात् तीन चार महीनों के अन्दर काम आरम्भ कर दिया जायगा।

†[THE DEPUTY MINISTER OF DEFENCE (SHRI K. RAGHURAMIAH): (a) The Ministry of Commerce and Industry have been informed that the Ordnance Factories can undertake manufacture of weights of 100 gms. and above. An estimate of the capacity available for each type of weight has also been intimated to them. We are now awaiting the receipt of actual orders for the weights from the various user Departments concerned.

(b) It is proposed to manufacture these weights at Gun and Shell Factory, Cossipore, Metal and Steel Factory, Ishapore, Harness and Saddlery Factory, Kanpur, Ordnance Factory, Dehra Dun, and Gun Carriage Factory, Jabalpur. The quantity to be manufactured at each factory will be determined with reference to the spare capacity available at the factories when the orders are received.

(c) The work will be started within a period of three to four months after the receipt of the order.]
