cement or because we are making extravagant use of cement?

SHRI J. S. L. HATHI: It is not that *we* are making extravagant use of cement but we feel the shortage of cement and for the purpose of economy we are mixing this.

DR. RAGHUBIR SINH: Is tt not true that certain experts have said that under certain conditions the use of tMs particular material is most inadvisable?

MR. CHAIRMAN: Certain other experts have said something else.

SHRI M. GOVINDA REDDY: May I know the annual consumption of cement in India as compared with other countries?

SHRI J. S. L. HATHI: We are using about 4-2 million tons of cement annually and now, as hon. Members know, our target is about 14 million tons in the second Five Year Plan.

INCOME FROM TOURIST TRAFFIC

•276. SHRI MAHESWAR NAIK: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state the income derived by Government from tourist traffic during the last three years?

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR): The foreign exchange earnings from tourists estimated by the Reserve Bank of India are as follows: —

1954 . . . Rs. 8·4 crores 1955 . . . Rs. 10·1 crores 1956 (Jan-June) Rs. 7·3 crores

The figures for 1956 are provisional and liable to revision.

SHRI MAHESWAR NAIK: May I know whether the income from tourist traffic is straightway taken to

the Consolidated Fund or whether it is being distributed to the States concerned?

SHRI RAJ BAHADUR: The income from tourist traffic is income from the tourists who incur expenditure in so many ways when they go to so many places, during their visits to this country. But the overall position is that the country gains foreign exchange from whatever is spent in the country during these visits

SHRIMATI MAYA DEVI CHETTRY: May I know the income derived from each State during the period mentioned here?

SHRI RAJ BAHADUR: I think the hon. Lady Member means countries from which we have been getting, tourists.

SHRIMATI MAYA DEVI CHETTRY: No, I meant States

SHRI RAJ BAHADUR: State-wise it will not be possible to give figures, because they go about the country and spend money in different parts of the country.

SHRI V. K. DHAGE: Is Government taking any steps to improve tourist traffic in order to earn more foreign exchange and if so what are those steps?

SHRI RAJ BAHADUR: We are taking quite a few steps to encourage tourism.

Other works, including widening road crust to 22ft. from Rohtak to Hissar, are provided in the 2nd Plan and will be undertaken as funds become available. Due to shor-

tage of funds this year further new works are not proposed to be sanctioned until the next year.
