THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION AND SCIENTIFIC RESEARCH (Dr. K. L. SHRIMALI): (a) 780.

(b) It is estimated at Rs. 216 p.m.

SHRI M. VALIULLA: How many are published, Sir?

Dr. K. L. SHRIMALI: I do not have the actual number of publications.

DR. RAGHUBÍR SINH: May I know, Sir, whether this journal is running at a loss?

DR. K. L. SHRIMALI: Yes, Sir.

PAKISTANI FOREIGN MINISTER'S STATE-MENT ABOUT THE LANDING OF RUS-SIAN PLANES IN KASHMIR

- 6. Shri AWADHESHWAR PRASAD SINHA: Will the Prime Minister be pleased to state:
- (a) whether Government's attention has been drawn to a statement reported to have been made by Mr. Feroz Khan Noon, Foreign Minister of Pakistan, in answer to a question in the Pakistan National Assembly that "Russian planes are known to have been landing in Kashmir and the whole of India can be considered a Russian base":
- (b) whether there is any basis for the allegations made; and
- (c) if the answer to part (b) above be in the negative, what steps Government have taken to counter the allegations?

THE PRIME MINISTER AND THE MINISTER OF EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) Government's attention has been drawn to certain press reports of the statement.

(b) There is not an iota of truth in the allegations made and it is surprising that the Foreign Minister of Pakistan should make statements which have no basis whatever. The statement that "Russian planes are known to have been landing in Kashmir" is completely untrue. No Russian plane has landed there except when the Soviet leaders, Mr. Khrushchev and Mr. Bulganin and their party visited Srinagar during their visit to India in 1955. They went there on their own aircraft Ilyushin 14.

The statement that the whole of India can be considered a "Russian base" is so fantastic and perverse that it is difficult to imagine that even the Foreign Minister of Pakistan believes in it.

(c) We have contradicted these allegations publicly and are bringing this also to the notice of the Pakistan High Commission.

SHRI AWADHESHWAR PRASAD SINHA: Is it a fact, Sir, that due to her commitments concerning S.E.A.T.O. and other military aid deals, Pakistan has been allowing the landing of military planes and also the use of her air bases to the foreign countries concerned?

MR. CHAIRMAN: That question does not arise from this. You were asking about the Foreign Minister's statement, and now you are asking whether it is a fact that Pakistan is being used

SHRI AWADHESHWAR PRASAD SINHA: May I know, Sir, whether these false allegations against India are deliberately made to hide Pakistan's own plight in this respect?

Shri JAWAHARLAL NEHRÜ: Either they are deliberately made or it is due to hallucinations.
