SHAH MOHAMMAD UMAIR: Is the Government aware that because of the non-introduction of half naya paisa, the public has to pay a greater amount in smaller transactions?

SHRI B. R. BHAGAT: It is a suggestion for action.

[SEIZURE OF SMUGGLED GOLD

•2. SHRI NAWAB SINGH CHAUHAN: Will the Minister for FINANCE be pleased to state:

(a) the quantity of smuggled gold seized in the country during the last two months; and

(b) the quantity and value of smuggled gold seized at each place and the names of the countries from where it was smuggled?]

वित्त उपमंत्री (श्री बी० आर० भगत) :

(क) सीमा-शुल्क-अधिकारियों ने १९५७ के मार्च और अप्रैल के महीनों में चोरी-छिपे लाया गया कुल १८,५३४ तोला सोना और १८४५ सावरेन पकड़े ;

(ख) प्रत्येक स्थान पर चोरी-छिपे लाये गये और पकड़े गये सोने की मात्रा तथा कीमत का और जिन देशों से सोना चोरी छिपे लाया गया उनके नामों का एक विवरण सभा की मेज पर रख दिया गया है ।

†THE DEPUTY MINISTER FOR FINANCE (SHRI B. R. BHAGAT): (a) The total quantity of smuggled gold seized by the Customs authorities during the months of March and April 1957 was 18,534 tolas plus 1,845 Sovereigns.

(b) A statement showing the quantity and value of smuggled gold seized at each place and the names of the countries from where it was smuggled is placed on the Table of the Sabha. [See Appendix XVII, Annexure No. 1].

श्री नवाब सिंह चौहान : क्या सरकार यह बतलाने की कृपा करेंगी कि जिन देशों से, जैसे कि गोआ और पाकिस्तान से, भारत में सोना आ रहा है उसको रोकने के लिये उसने क्या क्या प्रयत्न किये हैं और उसमें क्या-क्या सफलताये मिली हैं ?

श्री बी० आर० भगत : अभी पिछले महीनों में गोआ या पश्चिमी तट से तो नहीं आया है, हाँ, पाकिस्तान से चोरी छिपे सोना लाया गया है और उसके लिये सरकार ने काफ़ी कार्यवाहियाँ की हैं, जैसे कि "इंटेलिजेंस" को नये ढंग से लागू किया है और जो राजस्थान और पंजाब की बार्डर पोलिस है उनको यह हक दिया गया है कि कस्टम्स आफिसर्स की पावर्स उनको होंगी और इसका नतीजा यह हुआ है कि काफ़ी मात्रा में पाकिस्तान से जो सोना आ रहा था वह रुका है ।

SHRI M. VALIULLA: May I know how many persons were arrested in this connection and how many were foreigners among them?

SHRI B. R. BHAGAT: I want notice for that.

SHRI J AS WANT SINGH: We often hear reports about the large quantities of gold that is being smuggled into this country. We hear of two theories. One is the profit motive of the smugglers, and the other is that there is some international conspiracy to harm India's economy. I want to know from the Government what in their view the reason is for the smuggling of such large quantities of gold into this country?

SHRI T. T. KRISHNAMACHARI: I have also heard stories similar to those that my hon. friend stated, but until we find that those stories have got some substratum of truth behind them, I am afraid I won't be in a position to answer the question that he has raised.

SHRI JASWANT SINGH: But what is the reason? .

SHRI T. T. KRISHNAMACHARI: The reason apparently is that the smuggler thinks that he can make money out of it.

SHRI M. GOVIND A REDDY: May I know whether the matter was taken up with the Government of Pakistan in order to evolve some co-ordinated measures to prevent this?

SHRI T. T. KRISHNAMACHARI: There are border police arrangements between States, but the hon. Member is also aware that these border arrangements between two States do not work as well as they ought to between Pakistan and ourselves.

PANDIT ALGU RAI SHASTRI: May I know as to why the Government is so panicky about gold being smuggled into this country when they want

jewellery from people as was evident from the Prime Minister's appeal?

SHRI T. T. KRISHNAMACHARI: The first part of the question I am not in a position to answer. But so far as parity is concerned, the value of gold has been fixed in terms of the value of the rupee, and this we have determined in agreement with the International Monetary Fund, and on that basis our transactions are going on. I think that the rupee value has been correctly fixed, but so far as gold is concerned, it sometimes seems to acquire scarcity value about which we can do nothing.

SHRI PRITHVIRAJ KAPOOR: May I know whether the Government is aware that the desire among the people to hoard gold and the attachment of so much sanctity to gold and to the possession of gold are responsible for the rise in the price of gold, and that this inspires people outside to bring gold into this country?

SHRI T. T. KRISHNAMACHARI: My hon. friend knows how to interpret human emotions. Human emotions acquire different forms, sometimes the acquisitive instinct turns towards property, sometimes women and sometimes gold. It happens in various ways.

SHRI R. U. AGNIBHOJ: May I know whether the smugglers were Indians or foreigners and whether the gold was smuggled into this country for value paid or without value being paid?

SHRI T. T. KRISHNAMACHARI: It is the same old story of who killed Cock Robin. If knew who was the smuggler, I would catch him.

SHRIMATI T. NALLAMUTHU RAMAMURTI: Is it not a fact that not only women but also men are responsible for this?

SHRI T. T. KRISHNAMACHARI: I apologise for having indirectly said something about women.

SHRI PRITHVIRAJ KAPOOR: May I know, Sir, whether the insecurity that prevailed in this country for centuries has been responsible for the desire to hoard gold and whether Government is doing anything to bring home to the people that now those days are over, we are a free nation and now we need not hoard gold. We should deposit it with the Government so that it could be utilised by them for the development works of the nation.

MR CHAIRMAN: It is a suggestion for action.

श्री नवाब सिंह चौहान : जैसा कि विवरण से जाहिर है, दो महीनों के अन्दर १८ हजार तोला सोना चोरी छिपे आया, १८ लाख रु० की कीमत का। क्या यह सच है कि पकड़े हुये सोने के अलावा भारत में प्रति दिन दस हजार तोला सोना आ रहा है? क्या सरकार को इसकी सूचना है?

श्री बी० आर० भगत : यह कहना मुश्किल है कि पकड़े हुये सोने के अलावा कितना सोना आ रहा है। मगर जो पकड़े गये भी मा० सदस्य ने दिये हैं वे तो बिल्कुल सच नहीं मालूम होते हैं।

DR. P. C. MITRA: May I know how the seized gold was disposed of?

SHRI T. T. KRISHNAMACHARI: It »11 depends upon the form in which it was got—it might have been taken over by the treasury.

t [SETTING UP OF A RE-FINANCE CORPORATION

(a) whether Government propose to set up a Re-finance Corporation and if so, what will be the objects and main features of the Corporation; and

(b) what will be its starting capital?

THE MINISTER FOR FINANCE (SHRI T. T. KRISHNAMACHARI) : (a) and (b). The proposal to set up a Corporation to provide medium-term loan assistance to industries in the private sector is still under consideration. The details which are being worked out will be announced shortly.
