|[THE DEPUTY MINISTER FOR EXTERNAL AFFAIRS (SHRIMATI LAKSHMX MENON) : (a) Two Indian soldiers, Havildar Dewan Singh, and Naik Puran Chand, were killed in a mine explosion on the 10th April 1957 in Gaza, while engaged in mine clearance.

(b) An amount of Rs. 250 each has already been paid from the Army Benevolent Fund to the next-of-kin of the soldiers. The credit balance and deferred pay amounting '6' Rs. 992' 93 in respect of late Naik Puran Chand have been paid to the next-of-kin, while in the case of the other soldier, it is being looked into.

The question of payment of Family Pension Awards is being examined.]

SHRI JASWANT SINGH: What is the difficulty in regard to the second soldier? In regard to the first case, it has been settled.

SHRIMATI LAKSHMI MENON: Sir, the next-of-kin in one case was the

SHRI JASWANT SINGH: Why not pay the immediate dues which are due to the next-ofkin?

(No reply)

SHRI M. VALIULLA: Are we getting any compensation from the U.N.O.?

SHRI JAWAHARLAL NEHRU: There, the salaries are paid by us. These are the hazards of such operations which we have to face.

SHRI MAHESWAR NAIK: May I know if these soldiers are treated as on active service?

SHRI JAWAHARLAL NEHRU: Of course, they are on active service.

SHRI KISHEN CHAND: May I know from the hon. Prime Minister whether these persons are not paid on the same scale as the other members of the Expeditionary Force of the United Nations? As such, their pensions and awards should be on a much higher scale.

SHRI .JAWAHARLAL NEHRU: So far as I know, each country that has supplied this Expeditionary Force pays for them itself. That is the normal pay. The special expenditure involved there, probably, is paid from a Fund. That Fund is normally also subscribed to by the members of the United Nations, to which every member has to pay some kind of a share. So far as their salaries and normal payments are concerned, we continue to pay as if they were in India. If any accident happens, we are naturally responsible for it. I do not know what responsibility the United Nations has in such matters. This is an accident; it is not a normal warfare. Undoubtedly, it is one of the hazards of such operations.

SHRI MAHESWAR NAIK: May I know whether this basic payment of Rs. 250 is considered to be adequate enough?

SHRI JAWAHARLAL NEHRU: This is not compensation. It was given out of the Army Benevolent Fund immediately to tide over the interval between the other payments.

Production in 1956 in this sector was about 6.8 lakh dozen bottles. Similar information is not available in respect of Cottage Scale Units.]
