SHOOTING OF GOAN NATIONALS BY PORTUGUESE AUTHORITIES

- 47. SHRI M. VALIULLA: Will the PRIME MINISTER be pleased to state:
- (a) whether any Goan nationals have been shot dead by the Portuguese authorities in Goa during the Jast five years; and
 - (b) if so, how many?

THE PRIME MINISTER AND THE MINISTER FOR EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) and (b). From time to time there are newspaper reports of shooting of Goan nationalists by the Portuguese Army and Police. Government of India have no diplomatic mission in the Portuguese Possessions in India and, thus, such shooting incidents -cannot be corroborated through any other source.

THE PRIME MINISTER AND THE MINISTER FOR EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) In most of the schools and universities in South Africa, there is racial segregation. In the Universities of Cape Town and Witwatersrand, where segregation does not exist, it will be enforced as a result of the "Separate University Education Bill", which is now before South African Parliament.

(b) The Government of India have already brought to the notice of the U.N. General Assembly the wider issue of the status of Indians in South Africa in general and have also condemned the various apartheid measures of the Union Government.

LOANS GRANTED BY NATIONAL INDUS-TRIAL DEVELOPMENT CORPORATION LTD., TO TEXTILE AND JUTE MILLS

- M. GOVINDA 50. Shri REDDY: Will the Minister for COMMERCE AND INDUSTRY be pleased to refer to the reply given to Starred Question No. 133 in the Rajya Sabha on the 7th August, 1956 and state:
- (a) how many loans and of what value have so far been granted by the National Industrial Development Corporation Ltd.; to textile and jute mills; and
- (b) what are the terms under which such loans have been granted?

THE MINISTER FOR COMMERCE AND INDUSTRY (SHRI MORARJI R., DESAI): (a) Loans to four jute mills and one cotton mill have been approved in principle: but formalities have been completed in respect of two jute loans only and a sum of about Rs. 46 lakhs paid as instalments.

(b) The loans carry interest at 4£ per cent per annum and are repayable in 15 annual instalments. They
