- (iv) Indian Embassies in foreign countries have been requested to use Indian Fruit Products wherever possible in order to popularise them.
- (v) Indian fruits and tinned fruit products are displayed in almost all the fairs and exhibitions in foreign countries where India participates. The Cashew and Pepper Promotion Council has taken special steps to find out new markets for Indian Cashewnuts by sending a delegation to most of the European countries.

It is too early to assess the extent to which these have succeeded in stepping up export of fruits and fruit products.]

CONSTRUCTION OF A TUNNEL UNDER THE BRAHMAPUTRA RIVER

78. SHRI M. VALIULLA: Will the Minister for Transport and Communications be pleased to state:

- (a) whether Government have any proposal under consideration for the construction of a tunnel under the Brahmaputra river near Gauhati; and if so, what are the details of that proposal;
- (b) if the answer to part (a) above be in the negative, whether there is any other alternative scheme under consideration; if so, what is that scheme; and
- (c) whether any foreign firm has been consulted in this matter; and if so, which is that firm?

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR): (a) and (b). The following proposals are under consideration:

- (i) Constructing a road bridge over the Brahmaputra river, or a tunnel under the river bed, at Jogighopa or near Gauhati;
- (ii) Constructing a rail-cum-road bridge at a suitable site.

The preliminary investigations carried out so far indicate that the tunnel project may not be a practical proposition on account of the high cost involved.

DEATH OF MONKEYS ON A LARGE SCALE IN AND AROUND PURANA OLLA

- 80. SHRI MAHESWAR NAIK: Will the Minister for HEALTH be pleased to state:
- (a) whether any enquiry has been instituted by Government into the death of monkeys on a large scale in and around Puxana Qila at Delhi towards the end of the month of March 1957; and
- (b) if so, what are the findings of the enquiry?

THE MINISTER FOR HEALTH (SHRI D. P. KARMARKAR): (a) Investigation regarding the death of monkeys near Purana Qila was made by the Health Department of Delhi Administration.

(b) Some truck loads of young monkeys in a sick and debilitated condition were released by some one in the Purana Qila area on the evening of 20th March 1957, just before the onset of hailstorm. A considerable number of young monkeys died during the night of the hailstorm and subsequent days in the forested area. The cause of death of these monkeys was the combined effect of sickness, physical trauma and starvation. In order to trace the culprits a complaint has been lodged with the police for an offence punishable under section 290 I.P.C. and the matter is under investigation.
