### WRECKAGE OF TWO BOATS NEAR PORT BLAIR

SAVITRY DEVI 177. Shrimati NIGAM: Will the Minister for HOME Affairs be pleased to state what action has been taken against the per sons who were held responsible for the wreckage of two boats near Port Blair as a result of the enquiry held in this connection?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): Government are not aware of any boat being wrecked near Port Blair. Two foreign vessels, however, namely, s.s. 'INCHKE-ITH' and s.s. 'SEMIRAMIS' ran aground off Port Meadows and Landfall Islands respectively on the 2nd March 1955 and 22nd May 1955. The vessels being foreign, the question of taking action against the persons responsible for the ships running aground does not arise and the Anda-mans Administration did not hold any enquiry in the matter.
