

(b) The trains concerned are detailed in the attached statement. [See Appendix XVII, Annexure No. 35.]

The Dining Car service running on train Nos. 63 Up/64 Dn. Howrah-Delhi Toofan Express is proposed to be taken over for departmental working from 1st June 1957.

A proposal is also under consideration to provide a departmentally-run catering service on trains Nos. 204 Dn./203 Up Ahmedabad-Delhi Express.

On the other trains, there is no proposal, at present, to replace the private contractors by departmental catering.
