f[THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI HUMA-YUN KABIR): (a) During the First Five Year Plan period, the progress of road construction in Sikkim was rather slow due to extreme shortage of labour and other initial difficulties peculiar to that region. The progress, however, improved considerably during 1956-57 and this is being kept up.

(b) Does not arise.]

#### POWER HOUSES OF THE BHAKRA NANGAL PROJECT

- •230. SHRI JAI NARAIN VYAS: Will the Minister for IRRIGATION AND POWER be pleased to state:
- (a) the number and the names of the Power Houses of the Bhakra Nangal Project which have started supplying electricity and the areas in which this electricity is being supplied; and
- (b) the names of the Power Houses which are expected to start functioning during the current year?

THE MINISTER FOR IRRIGATION AND POWER (SHRI S. K. PATIL): (a) Two Power Houses, namely Ganguwal and Kotla on Nangal Hydel Channel have started supplying electricity. The electricity generated at these Power Houses is being utilized in Delhi and Punjab.

(b) No power House is expected to start functioning during the current year.

# TESTING OF WATER IN DELHI

- \*231. SHRI JAI NARAIN VYAS: Will the Minister for HEALTH be pleased to state:
- (a) whether Government have been regularly conducting physical, chemical and bacteriological tests of water drawn from wells for human consumption and water used for manufacturing ice and aerated water in the different factories of Delhi; and

(b) if so, whether Government are satisfied that there is no pollution in the water used for the above purposes?

THE MINISTER FOR HEALTH (SHRI D. P. KARMARKAR): (a) and (b). Samples are taken by the Municipalities and also by the Director of Health Services, Delhi and sent for physical, chemical and bacteriological analysis. In case of contamination, steps are always taken to dis-infect the source of water supply. Water drawn from shallow wells is not always safe and the public is, therefore, regularly advised to use it after boiling.

खाद्य तथा कृषि मंत्री (श्री अचित प्रसाद जैन) : (क) जी नहीं । भारत में चावल के उत्पादन के ग्रन्तिम श्रनुमान १६५, ४-४६ की अपेक्षा १६४६-४७ में, जो द्वितीय योजना का पहला वर्ष है, १३ लाख टन की वृद्धि बतलाता है। गेहुं, दूसरे श्रनाज ग्रीर दालों के लिये १६४६-४७ के उत्पादन के अन्तिम अनुमान अभी तक प्राप्त नहीं हुए हैं । परन्तु प्रोविजनल एडवान्स (provisional advance) अनुमान यह बतलाते हैं कि एक लाख टैन से अधिक अतिरिक्त उत्पादन होगा । इसलिये खाद्यान्नों (ग्रनाजों और दालों) में उत्पादन की कुल बढ़ौत्री १६४५-४६ की अपेक्षा, १६४६-४७ में कोई १४ लाख टन से भी ग्रधिक होने की संभावना है। टेमो ग्रनाजों ग्रीर दालों के उत्पादन पर खराब मौसम के कारण बुरा असर पड़ा। यह ध्यान देने की बात है कि खाद्याक्षी के ग्रतिरिक्त उत्पादन का लक्ष्य, १६५६-५७
