APPOINTMENT OF FOREIGN EXPERTS ON COMMITTEE ON FLOOD CONTROL

*195. SHRI M. GOVINDA REDDY: Will the Minister for IRRIGATION AND POWER be pleased to state the names of the foreign experts who have been or are proposed to be appointed on the high power committee appointed recently to examine the question of flood control?

THE MINISTER FOR IRRIGATION AND POWER (SHRI S. K. PATIL): The selection of one or two American experts for appointment on the High • Level Flood Committee is still under consideration by the Government of India in consultation with Technical Co-operation Mission authorities. It is premature to give the names at this stage.

SHRI M. GOVINDA REDDY: May I know whether the Committee has been constituted?

SHRI S. K. PATIL: The Committee has been constituted, but there is the possibility of adding two more names.

SHRI M. GOVINDA REDDY: May I know what would be the scope of the Committee's enquiry?

SHRI S. K. PATIL: The scope of their enquiry is big and it would take time-but I would say it is mainly to analyse the factors responsible for the succession of heavy floods, to review the measures undertaken so far, to lay down principles for fixation of priorities in the construction of- protection, to examine specific flood problems and any other recommendations bearing on these protections.

SHRI MAHESWAR NAIK: May I know whether it was a fact that a similar Committee was appointed to go into this question of floods in J

North-west India which occurred a year or two back?

SHRI S. K. PATIL: It is a Committee that has got overall charge and therefore, it will look after the flood question as a whole everywhere.
