

**CONSIGNMENT OF FOREIGN CHICKS TO AID
POULTRY DEVELOPMENT**

18. SHRI M. VALIULLA: Will the Minister for FOOD AND AGRICULTURE be pleased to state:

(a) whether a consignment of chicks was recently received in India to aid poultry development; and

(b) if the reply to part (a) above be in the affirmative, whether these chicks have since been distributed in the country; if so, to which places?

THE MINISTER FOR FOOD AND AGRICULTURE (SHRI A. P. JATN) : (a) Yes, a consignment of 30,000 chicks and 8,640 hatching eggs has been received.

(b) About 7,100 chicks have been distributed to Indian Veterinary Research Institute, Izatnagar, and the States of Rajasthan, Uttar Pradesh, Punjab and Bombay (Nagpur). Chicks will be supplied to the States of Madras, Mysore, Andhra (Hyderabad), Kerala, Bombay (Poona), Orissa, Jammu and Kashmir, West Bengal, Bihar, Madhya Pradesh and Manipur shortly.
