DR. SHRIMATI SEETA PARMANAND: If the standard of teaching, as pointed out by the Health Minister, was low, how does it happen that students from so many countries come to this college of international repute?

Written Answers

RAJKUMARI AMRIT KAUR: Sir, the girls from British East Africa are Indians under scholarships; there is a girl from Nepal; the girls from Ceylon are also under scholarships. From Italy is a nun who has been working in an out of the way place in India and asked if she might be admitted to study in this college and become a doctor.

DR. SHRIMATI SEETA PARMANAND: Is it not a fact that the results of this college have compared very well with the results of the men's colleges and that is the reason why these women are coming to this college instead of going to the men's colleges?

## COLLISION BETWEEN GOODS AND PASSENGER TRAINS ON THE BIHAR-BAKHTIYARPUR LIGHT RAILWAYS

\*42. SHRIMATI SAVITRY DEVI NIGAM: Will the Minister for RAILWAYS be pleased to state whether Government had instituted any inquiry into the causes of the collision between the goods and passenger trains near Rasulpur village on the Bihar-Bakhtiyarpur Light Railways and if so, what is the result of that enquiry?

THE DEPUTY MINISTER FOR RAIL-WAYS AND TRANSPORT (SHRI SHAH NAWAZ KHAN): Presumably, the accident referred to is the head-on collision between a Down Passenger Special and an Up Goods Special between Harnaut and Wena stations of the Bakhtiyarpur-Bihar Light Railway on 16th January 1957.

A statutory enquiry into this accident was held by the Government

Inspector of Railways and his provisional finding is that the accident was caused due to the failure of human element on the part of the Railway staff.

SHRIMATI SAVITRY DEVI NIGAM: Was there any loss of life due to this accident?

SHRI SHAH NAWAZ KHAN: No, Sir, there was no loss of life.

SHRIMATI SAVITRY DEVI NIGAM: Is it a fact that one of the drivers was heavily drunk at the time of the-accident?

MR. CHAIRMAN: How does he know?

SHRI SHAH NAWAZ KHAN. No,. -, I do not know.

SHRIMATI SAVITRY DEVI NIGAM: It has been stated in the enquiry, Sir.

SHRI SHAH NAWAZ KHAN: The enquiry has not yet been finalised.
