## EARLY CLOSURE OF TEA PLUCKING SEASON

93. SHRI M. VALIULLA: Will the Minister for COMMERCE AND CONSUMER INDUSTRIES be pleased to state:

(a) whether it is a fact that the Calcutta Tea Regulation Committee has decided early closure of tea plucking season this year;

(b) if so, what will be the effect of this decision on tea production; and

(c) what is the reaction of Government in the matter?

THE MINISTER FOR COMMERCE AND CONSUMER INDUSTRIES (SHRI MORARJI DESAI): (a) to (c). Yes, Sir. It is understood that as a result there will be some reduction in the anticipated surplus. But the production of 1956 is, however, unlikely to fall below that of 1955. Government hope that the possibility of the absence of an excessive surplus, in present circumstances, will strengthen the tea markets both in India and abroad, as anticipated by the producers who have taken this action.
