over by the Director General of Shipping has recommended three standard types of ships for construction in India and this recommendation has been accepted.

- (b) The broad features of the three standard types of ships are:
 - (i) For overseas trade, a 9,500 tonner Open Shelter Decker (with scantlings for a 11,000 tonner Closed Shelter Decker) with a speed of about 16 to 17 knots.
 - (ii) For coastal trade, a 8,000 tonner Open Shelter Decker (with scantlings for 9,500 tonner closed shelter decker) with a speed of about 12 knots.
 - (iii) A 5,000 tonner Open Shelter
 Decker (with scantlings for a
 6,000 tonner Closed Shelter
 Decker) with a speed of about
 13 knots, also for the coastal
 trade.

EXTRADITION AGREEMENT WITH GOVERNMENT OF BURMA

REHABILITATION OF DISPLACED PER-SONS FROM EAST PAKISTAN IN MADHYA PRADESH

- 98. MOULANA M. FARQUI: Will the Minister for REHABILITATION be pleased to state:
- (a) whether any scheme for settling the East Pakistan displaced families in the reclaimed land in Madhya Pradesh has recently been drawn up;
- (b) if so, what is the total acreage of land reclaimed and the number of families to be settled there; and
- (c) what is the total acreage of land reclaimed so far in each State for the rehabilitation of displaced persons from Pakistan?

THE MINISTER FOR REHABILITATION (SHRI MEHR CHAND KHANNA): (a) and (b). Yes; a scheme for reclamation of 7,875 acres of Government forest lands in the districts of Raigarh and Sarguja (4,375 acres in Raigarh and 3,500 acres in Sarguja) for the rehabilitation of displaced persons from East Pakistan is under consideration. There are also possibilities of 30,000 acres of land being available in the Bastar district. No land has been reclaimed so far.
