] also heard a similiar complaint that there is some delay in the booking of luggage and also at the terminus where the luggage is to be handed over. We are making arrangements to have these matters expedited.

Written Answers

SHRI S. N. MAZUMDAR: Has the attention of the Government been drawn to the fact, Sir, that the reclining seat which has been provided is reclining only the head a little, but there is no provision for stretching the legs, which means a lot of difficulty for the passengers who have to sit in that condition for the whole of the night?

Shri O. V. ALAGESAN: The hon. Member may have travelled in an aeroplane, and the seat that has been provided in this tran is much more comfortable than in an aeroplane, and the fare that is paid is the third class fare, which is perhaps the lowest in the world, plus four pies surcharge per mile. I think this is the greatest comfort that the Railways are providing at cheapest cost.
