Amount of loan.-500 million roubles (about 55-60 crores of rupecs).

Terms on which the loan has been accepted.—The Government of the U.S.S.R. have offered to supply industrial equipment up to a total value of 500 million roubles (about 55-60 crores of rupees) over a period of three years from 1959-61, on a long term credit basis.

The credit terms offered are. (including the period of repayment, rate of interest etc.) similar to those for the Bhilai Steel Plant. According to these terms the credit raised, shall be repaid in 12 equal annual instalments payable on or before the 15th day of March of each and every year following the year in which each such credit is raised. Interest will accrue at $12\frac{1}{2}$ % per annum from the date on which each particular credit is raised and will be similarly paid on or before the 15th day of March of the following year.

The projects for which the offered credit could be utilised are being examined by the Government.]

Capacity for heavy castings of iron and steel as well as for heavy forgings will be developed by the National Industrial Development Corporation in one integrated unit. Competitive quotations along with detailed project reports are being awaited from a British, a German and a Czechoslovakian firm and final decisions will be taken when these have been received. Capacity for fabricating certain categories of structurals will be set up near the steel plants by the N. I. D. C. and detailed examination of schemes submitted to Government are under examination.
