*300. SHRI NAWAB SINGH CHAUHAN: Will the Minister for HEAVY INDUSTRIES be pleased to state the work so far done by Mr. Harry J. Robinson who has come to India on behalf of the Ford Foundation and the manner in which and the extent to which India has been benefited by his advice and work?]

†[THE MINISTER FOR HEAVY (Shri INDUSTRIES Manubhai SHAH): Mr. Robinson has been working since January this year as an Economic Consultant whose main function is to promote collaboration between Indian firms and firms in the U.S.A. in the industrial field. A good number of Indian firms have been put in contact with suitable American parties by him and from all indications it seems that his work is proving useful though it would be premature to make any final assessment at this stage.]

Delivery of West Pakistan Cement to East Pakistan

*304. SHRI M. GOVINDA REDDY: Will the Minister for COMMERCE AND CONSUMER INDUSTRIES be pleased to state:

- (a) whether the Government of India has received recently any request from the Government of Pakistan for the delivery of the entire quantity of cement to be supplied to India by West Pakistan to East Pakistan; and
- (b) if so, what decision has been taken by Government in the matter?

THE MINISTER FOR HEAVY INDUSTRIES (SHRI MANUBHAI

SHAH): (a) and (b). Pakistan Government proposed that out of the quantity of cement supplied by them to India on the Western border, a small proportion should be supplied by India to East Pakistan. This proposal has been accepted.

SHRI M. GOVINDA REDDY: May I know, Sir, under what conditions this proposal has been accepted?

SHRI MANUBHAI SHAH: A part of the quantity that they will supply to us, we shall pass on to East Pakistan at the price of Rs. 102 per ton.

SHRI M. GOVINDA REDDY: May I know, Sir, whether the order placed by the Government of India with the Industrial Development Corporation of Pakistan for supply of cement has been honoured by the Corporation?

SHRI MANUBHAI SHAH: Yes, Sir. It is being honoured and the terms have been finalised.

SHRI M. GOVINDA REDDY: May 1 know, Sir. how much cement has been received?

SHRI MANUBHAI SHAH: So far, Sir, a small quantity of 7 thousand tons has come, and more is expected very soon.

SHRI M. GOVINDA REDDY: At what rate this cement has been supplied?

SHRI MANUBHAI SHAH: There are different terms and conditions for different quantities from time to time. The latest is Rs. 102 per ton.

SHRI M. GOVINDA REDDY: Is it not a fact, Sir, that the internal price of cement in Pakistan was fixed at Rs. 75 per ton, and it was supplied to other foreign countries at Rs. 82 per ton, and they have fixed an indiscriminate price for India?

SHRI MANUBHAI SHAH: That is not quite a fact. The price has varied from time to time. We look to the price that we are paying for foreign cement from other countries, and if the trans-

action is favourable to us, we accept it.

SHRI MAHESWAR NAIK: May I know whether there was any condition precedent that out of the total quantity of cement received from West Pakistan the whole or any part will be supplied to East Pakistan?

SHRI MANUBHAI SHAH: Sir, that is merely a friendly gesture because of the difficulty of transport and the neighbourhood of certain factories. The Pakistan Government proposed that out of the quantity of cement supplied by them on the Western border, some proportion should be supplied to East Pakistan, and that proposal has been accepted.
