Oral Answers

SHRI DEOKINANDAN NARA-YAN: May I know if any Professor from the staff took part in these disturbances?

DR. K. L. SHRIMALI: As far as my knowledge goes, no.

Shri DEOKINANDAN NARA-YAN: May I know how many students were arrested and prosecuted?

SHRIMALI: There DR, K. L. were no arrests.

SHRI DEOKINANDAN NARA-YAN: May I know if it is a fact that an effigy of our Prime Minister was taken out in procession and burnt?

Dr. K. L. SHRIMALI: No, as far as I know, no effigy of the Prime Minister was burnt but the effigy of Mr. K. M. Munshi was burnt.

DEOKINANDAN NARA-Shri YAN: May I know if Gita was also burnt?

DR. K. L. SHRIMALI: No, that is absolutely wrong.

Dr. K. L. SHRIMALI: In the procession which passed, there were students of all communities.

SHRI BHUPESH GUPTA: About these unfortunate incidents, statements were made by the spokesmen of the Government of India and the Government of Uttar Pradesh and the statements were contradictory other. May I know what steps Central Government took in order to find out which was not telling the truth?

Dr. K. L. SHRIMALI: I am responsible for only those statements that I make in this House. 10-Shri Deokinandan Narayan.

Mr. CHAIRMAN: Ouestion No.

DEOKINANDAN NARA-Shri YAN: Sir, may I request that this question be postponed to a further date as I have just got this long statement which I could not read within two minutes.

MR. CHAIRMAN: You put another question. This cannot be postponed.

REPORT OF THE TRAVANCORE-COCHIN BANKING ENQUIRY COMMISSION

- *12. SHRI S. C. KARAYALAR: Will the Minister for Finance be pleased to state:
- (a) whether the Travancore-Cochin Banking Enquiry Commission has submitted its report; and
- (b) if so, whether any action has been taken thereon?

THE MINISTER FOR REVENUE AND DEFENCE EXPENDITURE (SHRI A. C. GUHA): (a) Yes, Sir.

- (b) The recommendations are under consideration and decisions will be taken as early as possible.
- SHRI S. C. KARAYALAR: May I ask whether the decisions taken thereon will be applicable to the entire area comprising the former State of Travancore-Cochin or only to that part of the Travancore-Cochin State which is now a part of the Kerala State?

SHRI A. C. GUHA: The original Report covered the banks of only that part of the Travancore-Cochin State which previously formed the Travancore-Cochin State and not the present State. I think any action will only cover banks of that portion which formed the Travancore-Cochin State at the time of the setting up of the Committee.

SHRI PERATH NARAYANAN NAIR: May I know, Sir, if the Government intend to publish the Report?

SHRI A. C. GUHA: Yes, already it is under print and as soon as the Government's decision is taken, it will be released.
