that we must find ways of preventing the development of tuberculosis disease in persons who have already been infected, i.e.. the tuberculin potitives, because the disease we are finding now-a-days is largely coming from the positive persons in the community. I also said that in the U.S.A. and some other countries like the U.S.A., where the infection rates have been falling rapidly to a low level, I see little reason to talk now about increasing the use of B.C.G. To imply that these remarks referred to India, where the tuberculosis problem is quite different from that in the U.S.A.. is obviously to distort and misquote my views."
