- (//\*) Vidyalayas.—24 Vidyalayas have started functioning. Arrangements have been finalized for the starting of the 6 remaining Vidvalayas. 714 instructors and 306 Mistries are under training.
- Parishramalayas.—140 Parishramalyas are operating and arrangements have been finalized for the opening of the remaining 160 Parishramalayas. 6,151 spinners are under training.
- (iv) Production.—3,662 pounds of Ambar yarn have been spun in Vidyalayas and Parishramalayas and 3,602 sq. yards of cloth

#### Part (b) of the Question—

Demand has so far been received only from Madras for 2,500 Ambar Charkhas and 5 Parishramalyas; from PEPSU for 2,000 Charkhas and 4 Parishramalyas; from Madhya Pradesh for 300 Charkhas and 1 Parishramalya and from Delhi for 400 Charkhas and 1 Parishramalya. These demands have been sanctioned.
