many new centres are they going to choose in the next Five Year Plan?

Dr. P. S. DESHMUKH: We have got a very big plan indeed; we want to expand the area of about 104 of the existing artificial insemination centres so as to provide two additional key villages in each centre. This will cost nearly Rs. 35,59,000. Then we want to start 124 new artificial insemination centres each with six key villages to cover 5,000 cattle of breeding age. The expenditure involved is about Rs. 11,44,00,000. For the establishment of 51 artificial insemination centres with 306 key village units the expenditure involved is Rs. 5,00,000 and so on.

SHRI DEOKINANDAN NARA-YAN: How many villages will be covered during the coming five years?

DR. P. S. DESHMUKH: I have not made the calculation. It is a very large number of villages. I am afraid I cannot calculate the total number.

PROF. G. RANGA: Is anything being done to prevent temple bulls from being put into service in those areas where artificial insemination is being utilised?

DR. P. S. DESHMUKH: Some of the temple bulls are very good, but the scheme involves castration of scrub bulls so that good breeds alone will be bred.
